Be it known, that on the _____ day of _____ LB International, Inc. (hereinafter referred to as "contractor") and

(Client's name, hereinafter sometimes referred to as "client") do hereby enter into contract under the following terms and conditions.

1. Contractor hereby agrees to furnish the following:
 - One speaking engagement on _____ from approximately _____ to _____.
2. Additional presentations requested of contractor outside the terms of this agreement are subject to additional fees.
3. In consideration of the services described above, client agrees to pay to contractor a speaking fee of

\$ _____ (airfare and meals included in fee) and will provide, pay for, or reimburse, the costs of lodging and ground transportation for duration of the stay. The entire balance of \$ _____ shall be paid to contractor at the time of the speaking presentation with expenses paid within 14 days of receiving copies of the expenses from contractor, unless client pays for lodging and ground transportation at the time of the event. If the entire balance of the speaking fee is not received by the contractor at the time of the speaking presentation, the contractor reserves the right not to perform and client agrees to reimburse the costs of airfare and lodging for duration of stay and will pay 50% of fee to speaker.
4. Client agrees to provide ground transportation for the speaker (contractor) to and from airport, to and from hotel, and to and from event, or will reimburse speaker for the total cost of the duration of the stay.
5. Checks should be made payable to: **Lamont Brown**
6. Audio or video taping of the contractor's program(s) is not permitted in any means whatsoever by client or any audience member, unless with the expressed written consent of the speaker.
7. If speaking engagement is taking place at a college, university or high school, client agrees not to schedule speaking engagement(s) in a cafeteria, marketplace, or student union lobby during lunch or dinner hours. If client schedules speaking engagement(s) during lunch or dinner hours, the event must be held in a room separate from the cafeteria, marketplace, or student union lobby.
8. If program is satisfactory, client agrees to mail speaker a brief testimonial letter typed on company, association, or group letterhead within 14 days of speaking engagement and will provide three referrals of other individuals whose organizations may be able to benefit from the program.
9. If the engagement is canceled due to an Act of God or dangerous situation, all parties agree to reschedule the event with the same terms stated in the initial agreement. If the client cancels the scheduled speaking engagement within 14 days of scheduled event, the client is responsible for reimbursing speaker for any airfare expenses incurred. In the event of an emergency situation (i.e., personal/family-related illness, accident, death, other) that causes speaker to cancel; client may find a replacement speaker or the speaking engagement will be rescheduled or canceled and client will receive no expense reimbursement.
